



LLumar® Window Film Lifetime Limited Warranty For Marine Application

Eastman Performance Films, LLC (the "Manufacturer") warrants the LLumar window film products specified below ("Products") against crazing, peeling or delaminating when properly installed on suitable interior surfaces of glass windows by a LLumar dealer or installer (collectively, "Dealer") in accordance with Manufacturer's recommended installation procedures. Products covered under the Warranty are also warranted against unusual change of color; however, the Warranty does not cover fading or anything else other than specified herein.

LIFETIME LIMITED WARRANTY ("Warranty") for the following Products: CTX CH, IRX CH, AIR BL

If any of the foregoing Products fail to comply with the Warranty during the Warranty period, the Purchaser may obtain replacement and installation of the Product free of charge by any LLumar Dealer anywhere in the United States or Canada, per the terms and conditions of the Warranty stated herein. Manufacturer reserves the right to inspect any alleged Product failures.

This Warranty does not apply if (i) the original windows are altered, damaged or replaced, (ii) the Product is applied on glass that is not in totally enclosed areas on the boat or (iii) the Product is damaged as a result of improper cleaning and/or maintenance contrary to Manufacturer's recommendations*. This Warranty is made solely to the original Purchaser of the Product for as long as Purchaser owns the boat that Product has been installed. This Warranty cannot be transferred or assigned. This Warranty also does not cover improper installation. The Dealer and/or Dealer's installer is responsible for correcting any improper installation. The Dealer and/or Dealer's installer is not authorized to modify or extend any warranty coverage stated herein in any manner. This Warranty also does not cover any seal failures or thermal shock fracture to the glass. **Purchaser should check with Dealer and local regulations on limitations or requirements for visible light transmission for boat glass in conjunction with Product; however, in any case, for laminated glass applications, the Product to be installed must be at or higher than 30% visible light transmission.**

EXCEPT AS PROHIBITED BY APPLICABLE LAW, THE MANUFACTURER HEREBY DISCLAIMS LIABILITY FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL AND PUNITIVE DAMAGES ARISING FROM ANY CAUSE WHATSOEVER. EXCEPT AS EXPRESSLY PROVIDED HEREIN, THE MANUFACTURER HEREBY EXCLUDES AND DISCLAIMS ANY AND ALL EXPRESS WARRANTIES AND, EXCEPT DURING THE APPLICABLE LIMITED WARRANTY PERIOD SET FORTH ABOVE, THE MANUFACTURER HEREBY EXCLUDES AND DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

Some jurisdictions (states/provinces) do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above exclusions or limitations may not apply to Purchaser. This Warranty gives Purchaser specific legal rights, and the Purchaser may also have other rights which vary from jurisdiction to jurisdiction. The Product must be used in compliance with all applicable laws. Installation or use of this Product in a manner that violates any applicable law is a misuse of the Product and voids this Warranty, whether express or implied. It is the Purchaser's responsibility to ensure compliance with all applicable laws.

In order to obtain replacement of the Product, proof of purchase (original receipt) and this completed Warranty will be required by the Dealer to substantiate any Warranty claim. Proof of identity (e.g. - driver license) and ownership of the boat (registration or title) will also be required at the time of Warranty service.
